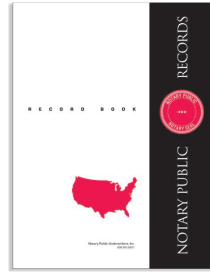

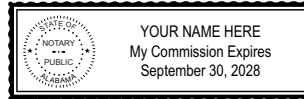

### Consider these Actual Cases:
